- 1. A system that measures rodent acoustic startle magnitude (peak and average) and latency as well as pre-pulse inhibition (PPI).
- 2. System has capacity to support four test stations for small/medium rodents (mice).
- 3. System can be adjusted (with additional hardware) to support smaller or larger rodents. (Indicate enclosure choices available.)
- 4. System can be enlarged to support additional test stations. (Indicate total number of test stations that can be supported.)
- 5. Cabinet for each station. (Indicate type of cabinet.)
- 6. Test stations are connected to system with USB ports. (Indicate type of port if other than USB.)
- 7. All cables, connectors, and supplies necessary to run the system are included.
