Proposals may be submitted by e-mail (smalligk@gvsu.edu), US mail, parcel, or drop off. No e-mail, telephone, fax or verbal quotations will be accepted. Indicate RFP #218-01 on your envelope or package or in the subject line of your e-mail. Grand Valley State University is not responsible for late, lost, misdirected, damaged, incomplete, illegible or postage-due mail.

3. Should it become necessary to revise any part of the RFP, notice of the revision will be given in the form of an addendum to all prospective suppliers on record as having received the RFP. Any addendum notices will also be posted on the [Bid Opportunities](#) page of the GVSU Procurement Services website www.gvsu.edu/purchasing. Each supplier should acknowledge receipt of addenda in their proposal, but the failure of a supplier to receive or acknowledge receipt of any addendum, shall not relieve the supplier of the responsibility for complying with the terms thereof.

4. In order to comply with the State of Michigan higher education appropriation bill, GVSU supports the following State of Michigan procurement requirements.

"Funds appropriated from the State shall not be used for the purchase of foreign goods or services, if competitively priced and of comparable quality American goods and services are available. Preference should be given to goods and services manufactured or provided by Michigan businesses, if they are competitively priced and of comparable quality."

5. All products and materials shall be new and all work shall be of good quality, free from defects. Do NOT quote on rebuilt equipment.

6. State full details of any warranties provided.

7. Do NOT substitute on the items unless the item is discontinued. Provide full information on any substitutes.

8. Quote each item individually. It is GVSU's intention to award this entire RFP to a single supplier unless there is substantial compelling reason to warrant otherwise. Please price assuming that you would be awarded all the items.
9. GVSU reserves the right to accept or reject any or all proposals or to negotiate with suppliers if it feels is in its best interest.
10. Include all costs in your proposal. Products are to be delivered F.O.B. Allendale campus.
11. Preferred delivery date would be August 1, 2017, but no later than August 8, 2017.
Delivery will be to the Allendale Fieldhouse arena which has an overhead door.
No installation is needed. State if there are any special delivery requirements.
